For your information

BT provides radio tower and site supervision for its site sharing customers in accordance with the BT's Code of Practice for Safe Climbing and BT Masts and Towers.

BT Rigging supervision will be required whenever any customer wishes to access a BT tower compound or climb a BT tower or mast. Access to the antenna galleries at BT Telecom Tower (London) or BT Tower (Birmingham) are classified and charged as 'Structure' access. BT will use its reasonable endeavours to provide Supervision in response to a properly submitted application form for a supervised visit to a BT Radio Station. A charge will be raised for the supervised visit.

BT cannot guarantee to provide Access or Supervision on demand regardless of requested Service Tier.

**Note - It is important to acknowledge that the customer may be required to pay for more than one supervisor, contingent upon H&S considerations, the scope of work, and the areas of

Full fees will be charged for supervision booked but cancelled with less than Two Working Days' notice.

Once supervision has been confirmed by BT, any amendment to the Supervised Access request or Permit to Climb will incur a £250 fee. A change of date may also result in a further additional charge.

Each access request is for an 8 hour day, minimum charge 1 day, Overtime charged at £75.00 per hour.

The fee covers up to 8 hours per day. Please note that includes up to 90 minutes each way travel time for BT personnel. If the travel time exceeds this then the customer will be notified. Earliest possible start time on site is 9am and the latest finish time is 5pm, subject to BT riggers assessment of acceptable daylight and/or weather conditions.

By exception, BT will consider requests for Supervision at Weekends or on Bank Holidays (Excluding Christmas Day, Boxing Day and New Year's Day) and we will charge a 25% premium on Tier 1 to 5 rates.

Explanation of additional charges:

Travel Charges

All exceptional (flights, ferry, helicopter and all-terrain vehicle hire etc) travel costs will be charged by BT at cost plus 15%.
